## **Toddler Program**

The Toddler program is for 2-year-old children who are enrolled at Manor. This program is available half day or full day, with Before Care being offered at our Rockville and Potomac locations and After Care at our Rockville, Potomac and Bethesda locations. Children do not need to be potty trained. The toddler program is led by experienced teachers and is specifically designed for the two-year-old child, as their first school experience. Parents provide diapers and wipes from home.

## **Primary Program**

The Primary program is for children ages 3-6. Primary children must be potty trained. This program is available half day or full day, with Before Care being offered at our Rockville and Potomac locations and After Care at our Rockville, Potomac and Bethesda locations.

# How to Register

Please submit a Summer Camp Application through our website [www.manormontessori.com](http://www.manormontessori.com). Manor families and alumni receive priority. Admission is on a first come, first serve basis.

## Payment

A non-refundable \$100 deposit is due with your application and applied to your first week's tuition. There is a 10% discount for siblings.

The entire balance for camp is due by May 16th.

Payments can be made by check made out to The Manor Montessori School to our main office or credit card & ACH bank transfer through your SchoolCues account. No tuition refunds will be made due to absences, health, weather, or withdrawal during a camp session.

## Required Health Forms

Children aged 3 ½ and older, as well as all currently enrolled students at Manor who submitted health forms for the previous school year, only need to fill out the attached **Youth Camp Health History Form**.

For children between 2 and 3 ½ years old, additional health forms are required to participate in camp. Manor will contact you directly to provide these forms.

If your child has any allergies and needs medication stored at camp the state of Maryland requires an **Allergy Action Plan and Medication Administration Form** be completed and signed by the child's doctor before the first day of camp.

If you child has asthma, the State of Maryland requires an **Asthma Action Plan and Medication Administration Authorization Form** to be completed and signed by the child's doctor before the first day of camp.

Additionally, if you would like a member of the Manor Staff to apply sunscreen, insect repellent, or diaper rash cream to your child, a **Topic Basic Care Product Application Authorization Form** is required by the State of Maryland. *Please note that these non-aerosol creams must be supplied by the child's parent.*
